Below please find my recap of the Town Board Work Session held last Thursday, September 1st. I have removed the 'Comment's section but feel free to e-mail me if you'd like it sent along.

This was a real record breaker. In and out in about 30 minutes. Wheeeeeeeee!

My favorite part was the 'Defibrillator' discussion which had a little bit of 'who's on first' flavor. Councilman Johnson couldn't seem to get a handle on where the units would be placed, who would use them (he mentioned adult supervision- huh?), how users would be trained and if the defibrillators would be locked behind glass and alarmed.

The most interesting parts of the meeting involves agenda item 5. If you have a moment read the commentary as it's about Route 22 and the Town Website.

As always the sardonic opinions expressed are mine and mine alone- besides, who would want them-

### WORK SESSION:

#### 1. Carol Court- Dedication of Road

Although there has been a drainage problem on Carol Court for 12 years Town Engineer, Tom Fenton, now feels the problem has been resolved. The Town will now take the road over. This will be on the September 15th agenda.

#### 2. Shady Lane- Road Name Change

The Board received a letter from a resident asking for the road name to be changed. Supervisor Dunford seemed to think that this would 'pit neighbor against neighbor'. According to the Town Attorney's office (represented by Willis Stephens) there are three houses on the road. The Board will speak to residents there.

#### 3. Purchase of Defibrillators:

The County will be paying for half of this purchase. The Board wanted to put them at the town beach, Markell Park, Wells Park (all three in summer) and the Highway Department. Councilman Johnson wanted them at Town Hall, Old Town Hall (court) highway and recreation. He asked who would use them and whether they would be in an area where there were adults.

The Board decided to order 5.

**4. Release of Performance Bond-Picarella Storage Building**

The Public Hearing will be scheduled on September 15th.

**5. Website Posting:**

The Board discussed whether or not to add a specific letter regarding Route 22 to their website. They decided that this would be appropriate.

**6. Eagles Ridge:**

The developer wants \$260,000 released so that various problems can be fixed. Supervisor Dunford asked if it would be better to pay bills directly. Willis Stephens said 'yes'. There will be a separate bond for the new buildings. It was mentioned that Wilder Balter had originally defaulted and that phase 3 had been purchased from said company.

**7. 2006 Putnam County Lake Management Program Application:**

This program must be applied for by October 21.

**8. March of Dimes**

This event will be on October 9th, announced at the September 15th meeting.

**9. Putnam County MS4 Mandate:**

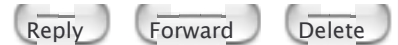
The County has asked all towns in Putnam County to support the \$2 a head stormwater mandate. Supervisor Dunford said he had reservations. "I'm a control freak." He said and continued that he worries that the county will share the money proportionately. According to our Supervisor every town except Kent and Southeast has signed on.

No one seemed clear on whether the \$2 was per household or per person.
