

## SE Town Board Work Session Recap 5/8/08

Hi All,

As has become my custom on Thursday nights I attended a SE Town Board meeting. Remarkably, I can actually say that this one was boring. Still I managed to jot down nine pages of pure drivel for the sake of some accuracy. The real question here is: how many times can the fab five tackle shoddily built dugouts, a bogus Sheriff's contract, agenda 'protocol' (like anyone behind *that* dais knows what this word really means) and last and certainly *least* in my mind is Southeast's very own 'Indian Point', the Minor Road stop sign. You know, these guys are making it really hard for me to come up with any new material.

Ugh... and how many updates on Volunteer Field do we really need? I have no doubt that it will soon come down to DMR intoning: "I just want to report that the grass at Volunteer Field grew a half inch last week." Or perhaps issue a four-color 'Dandelion Report'. And again with the men's softball league... Honestly, this has become like that excruciating blue-hair who inflicts a wrist-thick 'brag book' of unattractive grandchildren on you every time you accidentally meet in Hannaford's.

All answered 'no' until she got to the always inscrutable Mr. Rights who didn't seem all that keen on answering the question at all. I think Honeck felt slighted as she never even got to him.

I'll try to keep the 16 item agenda short as you've read it all before. And most items will be on the Regular Meeting's calendar next week. Oh goody.

As always the antagonistic, disparaging and unfair comments are my own take on the fractious and tedious travesty SE government has become. Thankfully these opinions reflect no organization to which I belong.

### **Town Board Work Session:**

#### **1. Minor Road Stop Sign:**

I missed this one but I was told that there may be another petition to install a stop sign.

#### **2. Gunning Street Light:**

I missed this as well but I believe it has to do with the street light at the corner of Drewville Road and Route 6.

#### **3. Agenda Protocol**

I missed this. I understand that this is why the agenda order was adhered to. Apparently there's protocol in Robert's Rules that can request that the agenda must be taken in order.

#### **4. Green Building Code:**

Planning Board Chair Tom LaPerch and our AKRF rep. gave a presentation on LEED's certification in order to codify green building codes within the Town. This would affect larger buildings (probably those over 10,000 square feet) and would only be required on new construction. It was mentioned that 100 Executive Park will have some green aspects. and that the Barrett Hill Senior Complex will be LEEDs certified (although to what extent was not clear).

The Stateline project was discussed. Mr. LaPerch was asked if any retail center in the Hudson Valley was LEEDs certified. Neither LaPerch or the AKRF rep thought so. The timeline on Stateline was discussed and it was asked if Stateline would have any green initiatives. Councilman Yee felt that if green initiatives were codified that because of the changing dynamic they should be reviewed every five years. Others felt that once a year would be more appropriate.

I asked that special care be taken on all senior projects as seniors are most often on a fixed income thus all energy saving measures should be taken. Also that it would be an excellent idea to build green initiatives into large retail spaces.

#### **5. Security:**

The missing vouchers were discussed with a representative from the security firm present to answer questions. The DVD requested by the Town Board to determine how the vouchers disappeared has since been taped over. There was a lot of back and forth including Supervisor Rights insisting that the storage of the vouchers in the lunch room wasn't secure. Ms. Mazzei said that it would have been impossible during daylight hours for someone to have taken the vouchers as they would have to get to the lunch room and then passed numerous offices with 7 boxes of vouchers. Councilman Honeck asked the rep why he hadn't reviewed the DVD after it was requested so that we would have some answers.

Honeck also asked the security rep if he worked for other municipalities. The answer: 'Yes'. It was decided that the new special districts manager, Levon Bogosian, would be in charge of security. Yee said that he trusted Levon but was concerned as Levon has worked for the town less than one month.

#### **6. Recreation Department- Field Usage by Non-Resident:**

There will be a charge of \$200 per field for non resident. Rights recommended \$1000 per league.

Rights update on Volunteer Field. Clay was to be ordered on Friday. The fence company will start next week.

#### **7. Contractor's Law:**

This is the law that was enacted to prohibit contractors from doing business with the town unless all their workers are documented.

Changes to the law were offered and were based on a Suffolk County law. Councilman Johnson said that the one page law that was written by Greg Ball was worthless. Again a lot of back and forth- no resolution reached.

#### **8. Stateline Project:**

The Board felt that this had been adequately covered under item number 4.

#### **9. Recreation Advisory Board:**

Ray Knox said that he didn't have a problem with an advisory committee that had a purpose, but did not want one that he had to report to as he had in the past. It was mentioned that since most residents want a pool it might be beneficial to reconstitute a committee to study this.

Johnson said that there was \$4 million in the recreation fund. Honeck asked Knox if it would make sense to move everything to the 10 acres near Toilly Foster- especially if a swimming pool and water park were built.

#### **10. Water Park Status:**

This will not be built this year. Because there is no swimming at Wells Park the enrollment has gone from 200 kids down to 35.

#### **11. Leaf Pick-up:**

Councilman Gross said that this had been a real concern when he was campaigning. Now there are 3 pick-ups a year which isn't enough. Especially as the bags are costly (\$2 a piece). Leaves are currently taken to the Highway Department.

## **12. Bond Counsel:**

Because of the major expenditures pending Supervisor Rights would like to switch bond counsel. Honeck and Johnson like the present counsel and Johnson said that after they had used larger firms had found ours cheaper. Rights would like to vote on this May 15th.

## **13. Sheriff's Contract Amendment:**

The Board agreed that it was important for the sheriff to attend a meeting to see what agreement could be reached re a contract revision.

## **14. Developer Impact Fees:**

Supervisor Rights would like developers to pay higher fees since the cost of schools, roads and fire districts are impacted by new development.

Town Attorney, Willis Stephens said that since impact fees had not held up in court. He then mentioned the Route 312 TID (Transportation Impact District) which had been looked at but never put into place as it had gotten 'bogged down'.

Rights suggested making impact fees voluntary.

## **15. Town Cell Phone Consolidation:**

Highway Superintendent Mike Fila had looked into this as highway personnel have town issued cell phones. The current charge for 14 phones is \$1000 per month. The new Verizon contract will be \$750 for 17 phones.

## **16. Development Impact Fees:**

See above.

## **17. Volunteer Park Dugouts:**

Contractor, Robert Conlin declined to appear before the board. Yee added up the building expenses which came to: \$29,941.

A spirited discussion on their construction ensued. It was determined that the dugouts had been knocked over by hand and that the roofs could be salvaged. In addition the dugouts had not been positioned correctly. The board will need to decide if the contractor should be sued.

## **COMMENTS/OPINION:**

### **Minor Road Stop Sign:**
